### ABOUT THE DIVISION

The Division of Alcohol, Drug and Tobacco Programs (ADTP) serves as an administrative office that contracts the majority of its federal, state and local funds to community-based, non-profit organizations.

ADTP is responsible for ensuring Contractor's compliance in accordance with applicable Federal, State and local laws, statutes, rules, regulations, guidelines and ordinances. Both informal and formal monitoring of contract objectives and use of funds are performed as well as technical assistance in program planning and implementation.

### PROGRAMS AND SERVICES

Multiple programs are delivered including:

- Screening, Brief Intervention and Referral to Treatment;
- Primary and secondary prevention services for adolescents and adults;
- Assessment & Referral Services;
- Residential & Outpatient Detoxification Services;
- Outpatient treatment for Adults including male and female specific, persons with co-occurring disorders;
- Residential Treatment for men, women and women with children;
- Narcotic replacement therapy services;
- HIV testing and early intervention services;
- Drug/Medi-Cal Treatment Services;
- First- and multiple offender drinking driver programs;
- Residential and outpatient services for parolees;
- Drug Court Intensive Outpatient Treatment Services for eligible Adults;
- PC1210 Treatment Services for eligible Adults;
- Tobacco Prevention and Cessation.

Eligibility requirements differ among the various contracted treatment providers. In all treatment agencies, a sliding scale fee, approved by the County Alcohol & Drug Administrator, is applied. Drug/Medi-Cal funding is also available for some treatment modalities. All alcohol and other drug-related services provided, through contract, with Marin County are available on a sliding-scale fee basis. Some outpatient and residential services are available for Medi-Cal recipients.

## DIRECTIONS AND MAPS

### Northgate Location (Occupied from Approximately September 2009 - October 2010)

#### From the Northern Marin County/North Bay

Take 101 South and Exit at Freitas Parkway  
Veer to the right and turn left at Northgate Drive  
Turn right into the Parking Lot at 899 Northgate Drive

#### From the Southern Marin County/South Bay/San Francisco

Take 101 North and Exit at Freitas Parkway  
Veer left at Manual T. Freitas Parkway  
Turn left at Northgate Drive  
Turn right into the Parking Lot at 899 Northgate Drive

### North San Pedro Road Location (Vacated Until Approximately October 2010)

#### From the Northern Marin County/North Bay

Take 101 South and Exit at the North San Pedro Road Exit  
Turn Left at the Stop Sign at the end of the exit ramp onto Merrydale Road  
Turn Left at the traffic light onto North San Pedro Road  
Turn Right at the intersection of San Pablo Road/Civic Center Drive (Marin County Civic Center will be on your left / gas station on your right)  
Turn Right into the Parking Lot at 10 North San Pedro Road  
Suite 1015 is on the First Floor.

#### From the Southern Marin County/South Bay/San Francisco

Take 101 North and Exit at the North San Pedro Road Exit  
Bear Right coming off the exit and merge onto North San Pedro Road traveling East  
Turn Right at the intersection of San Pablo Road/Civic Center Drive (Marin County Civic Center will be on your left / gas station on your right)  
Turn Right into the Parking Lot at 10 North San Pedro Road  
Suite 1015 is on the First Floor.
